Bids should be offered on prescribe bid/auction form of Federal Judicial Academy which will be obtained from Administration Branch of FJA, and should reach at the address given below till **19<sup>th</sup> March, 2018**, which will be opened on the same date at **11:00 am** in the presence of bidders who may care to attend.
2. The aforesaid vehicles can be inspected during office hours of the working days at the address mentioned below i.e 8:00 am to 3:00 pm till 15<sup>th</sup> March 2018.
3. Interested individuals/firms are required to bring their CNIC (in original) and attach fair attested copy along with sealed offers.
4. The vehicles will only be sold if highest offers are more than the reserve prices of the vehicles.
5. Taxes, (whatsoever admissible) will be charged as per prevailing Federal Government rules, besides bid price separately. (**10% advance tax for filer** and **15% advance tax for non-filer**).
6. If for any reason, the office is closed on the date of opening bids, it will be carried out on the next working day at the same time and place.
7. Each bid should be supported by 25% (twenty five percent) of the offered value as earnest money in shape of Demand Draft/Pay Order (refundable) in favour of Director General Federal Judicial Academy and the balance offered value, plus taxes as stated above will have to be deposited (in cash) within 10 days (ten days). Vehicles will be delivered only after full payment.
8. In case of non-deposit of the remaining payment (75% & taxes) on or before stipulated time, 25% advance/earnest money will be forfeited.
9. Successful bidder will have to transfer vehicle on his name within 15 days from the issuance of NOC by the Academy.
10. The Competent Authority reserves the right to accept or reject any bid.
11. Separate bid & payment instrument should be given for each vehicle.
12. The vehicle number/description of vehicle must be written on the top left corner of the envelope.
13. The employees of Federal Judicial Academy and their family members close or distant are not allowed to participate in bids.
