

"The nations always attain progress and prosperity through better management and better leadership in all walks of life-the leadership which promotes practicality, innovativeness and high standards, because such leadership firmly believes that there is no other short cut to progress, prosperity and peace." His lordship expressed these views in the certificate- awarding ceremony of one week training course on "The role of District and Sessions Judge/Senior Civil Judge, as being Non Financial Managers in Financial Management and other New Laws" for newly promoted District and Sessions Judges/Senior Civil Judges from all over Pakistan including Azad Jammu and Kashmir and Gilgit-Baltistan, held in the Federal Judicial Academy, Islamabad, on April 12, 2012.

About the judicial education and skill development, the Honorable Chief Justice of Pakistan said, "Judicial education and skill development are regarded as prioritized activities of the judicial academies for enhancing the quality and promoting standards of justice.

Judicial Academies are established as part of the judicial reform initiatives. In each country, judicial academies have tried to address both internal and external challenges faced by its judiciary. Indeed, they generate experiences and lessons which are of great significance. This premier judicial education institute of the country, the Federal Judicial Academy, is not lagging behind in this regard. Since, its genesis in 1988, this Academy has rendered a yeoman's service to the key

stakeholders of judicial system in imparting judicial and legal education and also intellectualizing and updating them with new trends and skills in the world of judiciary."

Quoting the golden words of a globally acclaimed political economist and author Peter F. Drucker about management which read as, "Management is doing things right; leadership

is doing the right things", his lordship said, "We should not and must not confuse bad management with destiny. Widespread poor management, mismanagement, non transparency and non accountability are considered as potential challenges to governance in any country."

Regarding effective "Financial Management", his lordship said, "Effective Financial management has become extremely important in the context of a changing socioeconomic environment around the globe. It is of vital importance to any state organization. Supporting efficient and sustainable public financial management is fundamental to the promotion of economic development, good governance, social progress and a rising

Management", "Case Management" and the "Knowledge Management", the knowledge on "Financial Management" and on the "New laws" which you have acquired here in the Academy, all of you can make a big difference, provided that you apply that knowledge earnestly and share it with others in the field, once you are back to your respective duty stations. Indeed, together, we can make a difference, we can mitigate the miseries of the litigant public and also we can manage and control the wastage of financial and other resources in this country".

"It is an axiomatic truth that continuing Judicial Education is one of the important means to develop judicial competence, enhance quality of justice and the performance of the courts. Judges must actively develop their new skills and they also must learn about the new laws and emerging trends in the judiciary in this globalized world in order to be more competent, thus ,the development of competence, in the case of a

judge, must be a reward in itself," his Lordship concluded.

Hon'ble Judge of the Apex Court was addressing the newly promoted District and Sessions Judges/ Senior Civil Judges from all over Pakistan including Azad Jammu and Kashmir and Gilgit Baltistan in the inaugural ceremony of one week refresher course on "The Role of District and Sessions Judge/ Senior Civil Judge being Non Financial Managers in Financial Management and other New Laws" at the Federal Judicial Academy, Islamabad, on Monday. He opined that the art of judgment writing and the conduct of court were two important aspects and the judges should focus on both these aspects.

He said that the judges of district judiciary should be kept abreast of contemporary changes and developments in the law, new skills and trends.

"Keep yourself abreast with the latest decisions of the Supreme Court. Perhaps, you will not be able to write judgments properly, if you are not abreast with the latest decisions and judgments. Above all, you must try to learn the basics such as how to conduct and act like a judge in the court," he maintained.

The Honorable Judge said that the judiciary had been completely transformed under the dynamic leadership of Mr. Justice Iftikhar Muhammad Chaudhry, Hon'ble Chief Justice of Pakistan.

"You have to follow his leadership, whose courage and vision has not only achieved the independence of judiciary, respect in the eyes of the masses, the legal fraternity but also he has

He expressed these views in the inaugural ceremony of one-week refresher course on, "Communication Skills" for Additional District and Sessions Judges from all over Pakistan including Azad Jammu and Kashmir and Gilgit-Baltistan at the Federal Judicial Academy, Islamabad, on Monday (23.4.2012).

Lamenting about huge backlogs of pending cases in the district courts, the Honorable Judge said, "It pains me to say that litigation in civil courts is infamous for its slow movement but sometimes even criminal cases take an incredibly long time to conclude."

Advising the participants, Honorable Judge said, "Promote reading habits; read good books, both, about your own subject of law and also about social sciences. Good reading habits are a source of knowledge and learning. I would like to advise you to establish some sort of library in your own home. Purchase at least one book from your own pocket, per month. Start

developing reading habit and make yourself a true book lover. I assure you that the habit of book reading will enhance your knowledge and wisdom, that will help you in your professional life."

Appreciating the course contents, the Honorable Judge, also threw light on the subject and said that it was crucial for the judges of district judiciary to develop communication skills for

effective administration of justice.

He further said, "There is no substitute for hard work and it is hard work which brings success. I would, therefore, like to advise you to work hard in your field and administer speedy justice to the litigant public."

He also advised the participants to always adhere to cardinal virtues of justice and realize the agonies of the litigants.

He said that it was the job of a judge to listen to the parties patiently and then decide the case as per law.

"Judges should be patient and courteous to litigants and others in the court. They should hear all proceedings with patience. If they hear with patience, they will understand the case at first instance and they will not face any difficulty to decide the case as per law and the cases will not accumulate," he maintained.

He emphasized, "Judges should be faithful to their duty and maintain professional competence. They should be un swayed by partisan interests, public clamor, or fear of criticism. They should not indulge in speculations. If judges are going to indulge in speculations, then, they will lose the track of justice."

About the content of the course, he opined, "It is well conceived and well designed training course. The participants should focus on the lectures and try to learn from the learned resource persons."

### Administration of justice creates balance in the society Hon'ble Mr. Justice Ejaz Afzal Khan

Judge Supreme Court of Pakistan, Hon'ble Mr. Justice Ejaz Afzal Khan said that judicial officers were some sort of engine which created balance in the society, saying, "Your wrong or unfair decisions bring imbalance, doom and destruction in the society."

Hon'ble Judge of the Apex Court expressed these views in the inaugural ceremony of one week course on "Various Subjects inclusive of National Judicial Policy and Role of District and Sessions Judges being Non Financial Managers in Financial Management" for twenty District and Sessions Judges from all over Pakistan including Azad Jammu and Kashmir and Gilgit Baltistan, at the Federal Judicial Academy, Islamabad, on Monday. About importance and scope of Judgeship, the honorable Judge said, "The seat we occupy, the job we do, is, indeed, job of God and that of the Holy Prophets and those judges who compromise their integrity, they will be debased and degraded in this world also."

"The Holy Quran and the teachings of the Holy Prophet (S.A.W) teach us, never to compromise our integrity," he elucidated.

Regarding the enforcement of Rule of Law and administration of justice he said, "The enforcement of rule of law and administration of justice, if you do it fairly and honestly, is such a task that would brighten your image. But those who do it otherwise will not escape the nemesis. They have to suffer, both, in this life and in the life hereafter."

About the importance of learning he quoted the last Prophet of Islam Hazrat Muhammad (S.A.W), "Rabbi Zidni Ilma" (Oh My Lord, Increase My Knowledge)." This Quranic verse, the Holy Prophet (S.A.W) recited till his last breath and that speaks of importance of acquiring knowledge.

awarding ceremony on the conclusion of one week course on "Various Subjects inclusive National Judicial Policy and Role of District and Sessions Judge being Non Financial Managers in Financial Management" for twenty District and Sessions Judges

from all over Pakistan including Azad Jammu and Kashmir and Gilgit Baltistan, at the Federal Judicial Academy, Islamabad, on Friday (29. 6.2012).

He asked the heads of district judiciary to be humble with the litigant public and others saying, "Humbleness should be our decoration. Integrity, knowledge and honesty should be our characteristics."

"As human beings we all should be humble and as judges we must be patient, attentive and God fearing," he elaborated.

Regarding speedy disposal of cases he said, "Whenever any case comes or a litigant appears before you, treat him like a patient who goes to the doctor for a proper treatment. You have to behave like a doctor. You know very well that any delay in the treatment on the part of a doctor can cause the patient a huge loss; it is also in your case. Always take the litigants as your dear and near ones."

About the National Judicial Policy, he said that the main reason and the objective behind this policy were to provide relief to the public as early as possible.

He urged the District and Sessions Judges to pass on their knowledge to the young judicial officers, "Since all of you are senior and experienced people and well versed with judicial knowledge and here also you would have benefited a lot from your colleague's knowledge and experience during interaction with one another and also with the learned resource persons because all of you come from different backgrounds and culture and from different parts of the country, therefore, I would ask all of you to transfer this knowledge and information to your junior judges as they should also be benefited with this knowledge and experience," he emphasized.

Woman and her status in every society has always been a vital subject of consideration among various scholars, intellects, gender activists and common public. In a country like Pakistan where despite severe efforts since many years women are still subjected to systemic gender sub ordination and her status largely varies from area, clan, family and society to which she belongs and that leaves a profound impact and influence on her life.

Woman in every walk of life has to face innumerable hardships and hurdles in proving herself. She is resisted, oppressed, coerced, intimated, harassed, molested and even killed whenever she raises her voice or opens her mouth and speak about her rights which are given to her not only by the law of the country but also by Holy Quran and Sunnah. Here, the question arises that if ALLAH who has the Supreme Authority and has stressed similar religious duties and obligations for both the sexes i.e:-

- a. Belief in ALLAH and His Messenger
- b. Praying
- c. Fasting
- d. Paying Zakat (Charity)
- e. Hajj.

Then why in a day to day life she has to confront with discrimination, biased attitude and male chauvinism, whether it is a petty domestic issue of food distribution or severe and serious issue of raising voice against the violation of her rights.

When women step out of their homes in expectation of provision of justice from the court of law, seeking security and redressal of their grievance even there also they are overburdened with difficulties. Litigants specially female litigants have always been an object of exploitation for those who are meant to protect them and extend justice in accordance with law.

It is undeniable that at present women litigants undergo extreme hardships and challenges when they appear before the courts of law. My consideration towards the topic is two fold and have given prominence to two serious issues with regard to female litigants and will strive to highlight and suggest reasonable solutions to address these problems.

### (A) 1. IGNORANCE OF LAW AND SYSTEM

It is unfortunate that 90% of women are unaware of their rights and laws which are formulated and enunciated for their protection, this is the main reason that lead them to erroneous path.

The most common appearances of female litigants are due to suits filed for dissolution of marriage. The environment of the courts is not decent enough for women and especially when she is not aware of the system and ill practices prevailing in the courts. They are misled and used by their own pleaders who instead of making efforts to reconcile the couple entice the women to further aggravate the differences between them.

In most of the families it is a sign of dishonor and shame if the woman from their family appears in the court. A famous case of Samia Sawar who was murdered in her lawyer's office on 6<sup>th</sup> April 1999 by a hitman hired by her family. She was seeking divorce from her estranged and abusive husband but this act of her was dishonorable for her family. Samia's Lawyer was charged for her murder and Hina Jillani and Asma Jehangir who were supporting her, they faced serious difficulties and threats for misleading women and contributing to country's bad image abroad.

It is not just one case but this practice is very common in rural areas where it is next to impossible for a female to appear in the court and fight for her right against some of the most evil and humiliating practices of our society such as

Child marriage Foot binding

Watta Satta Forced prostitution

Honour killing (Karo Kari)

Marriage to Quran

Trafficking

Marital rape

Acid throwing Murder of pregnant women

Breast Ironing Rape
Bride burning Sati

Dating violence Sexual slavery

Dowry death Sexual violence

Female genital mutilation Domestic violence.

It is largely due to unawareness and ignorance of law and even if she dares to take a step for protection of her rights out of sheer desperation and fear, she seeks shelter from those who are the protectors of her dignity and rights, though it is sad but true, that she enters into the world of indifferent people and experience skepticism and biased attitude against women's complaints of violence which are common among the Prosecutors, Police Officer and Medico-Legal Officers in Pakistan which results in:

Delays

Mishandling Misleading

Inadequate/improper investigation &

Abuse

### (B) SUGGESTIONS:

1. Formulation of programs to introduce awareness in female litigants regarding their legal rights particularly in rural areas.

- 2. Establishment of common room for female litigants to avoid eve teasing, touching and abuse by staff, advocates or other officers.
- 3. Adequate protection to female litigants who have security concerns inside and outside the courts.
- 4. Hiring of female staff specially in family courts.
- 5. Serious and stern actions should be taken against the officials who mistreat women litigants.
- 6. A separate committee should be formed for female litigants for providing guidance in engaging the pleaders.

### (A) ISSUE OF PRE-TRIALS, POST-TRIALS AND MEETINGS IN COURT:

The second issue is mainly related to my present city of posting which is Karachi. The issue that I have witnessed during my practice as an Advocate and now as a Judicial Officer is lack of proper meeting place or room for spouses and children. There is no concept of privacy of female litigants in pre and post trial proceedings because of lack of space.

Female litigants whether major or minor experience serious discomfort in such an environment where Police Officers and prisoners are roaming freely in courts which does not leave a healthy impression on their minds specially in the case of minors. Though there is a renowned and reputable centre at Karachi named as KCDR, a Center for Dispute Resolution whose Chairman is Zafar Ahmed Khan Sherwani, which has the facility of such a peaceful and private environment which is the foremost priority of the parties but that again is meant for certain class of people because of high charges the counselors claim for each meeting which is surely unaffordable and out of question for poor people. Courts are their only hope where there is inadequacy of space and it is the requisite for a female litigant to have that level of comfort in the court where she can discuss her personal problems openly and it would be convenient for the Presiding Officer as well to comprehend the main bone of contention between the parties.

Due to lack of space and privacy, peeping and teasing of staff is common problem that female litigants face because the chambers are mostly partitioned into office and chamber by placement of cupboards.

A healthy and complete family is a requirement of a better functioning of society that is the reason why so much importance is attached to the reconciliation proceedings.

Object of S. 10 is to bring about reconciliation between the spouses and to keep the family unit intact and save the parties from ordeal of future litigation (2002 SD 214)

### (B) **SOLUTIONS:**

- 1. Infrastructure should be revised specially to facilitate female litigants.
- 2. Segregation of the courts should be done in such a way that Judicial Magistrate should not be allowed to entertain family matters because of the presence of Police Officers and prisoners in the court rooms that may leave a negative impact in the minds of minor and major female litigants.
- 3. A separate room with all the basic facilities should be made inside or outside the courts for such proceedings.
